RESOLUTION NO. 2025-66

A Resolution adopting the estimated tax budget of the City of Mount Vernon, Mount Vernon, Ohio, for the fiscal year beginning January 1, 2026, and submitting the same to the Auditor of Knox County, Ohio.

RESOLUTION NO. 2025-67

A Resolution authorizing and directing the Auditor of the City of Mount Vernon to make supplemental appropriations.

RESOLUTION NO. 2025-68

A Resolution authorizing and directing the Safety-Service Director of the City of Mount Vernon, Ohio to enter into contract with Central Ohio Technical College for the lease/purchase of property; and declaring an emergency.

ORDINANCE NO. 2025-14

An Ordinance declaring the improvement of certain real property located in the City of Mount Vernon, Ohio to be a public purpose; creating the Liberty Crossing Incentive District; declaring the improvements to real property within the Incentive District to be a public purpose; declaring such property within the Incentive District to be exempt from real property taxation; describing the public infrastructure improvements made or to be made to directly benefit or serve the parcels for which improvements are declared to be a public purpose; requiring annual service payments in lieu of taxes during the periods of exemption; establishing a municipal public improvement tax increment equivalent fund for the deposit of such service payments; authorizing the execution of a tax increment financing agreement; and approving related matters.

ORDINANCE NO. 2025-15

An Ordinance declaring the improvement of certain real property located in the City of Mount Vernon, Ohio to be a public purpose; declaring such property to be exempt from real property taxation; designating public improvements to be made that will benefit such property; requiring annual service payments in lieu of taxes; and establishing a municipal public improvement tax increment equivalent fund; and authorizing the execution of a tax increment financing agreement.
