

## **Legislation Passed by Mount Vernon City Council, December 8, 2025**

### Public Notice

The following legislation was passed by Mount Vernon City Council on December 8, 2025, signed by Bruce Hawkins, President of Council, approved by Matthew Starr, Mayor, and attested by Zachary Sherman, Clerk of Council. The legislation is on file with the Clerk of Council, 40 Public Square, Mount Vernon, Ohio for public inspection.

### RESOLUTION NO. 2025-118

A Resolution authorizing the Safety-Service Director to advertise for bids and enter into contract for the Mansfield Avenue and Cottage Street sanitary improvements project; and declaring an emergency.

### RESOLUTION NO. 2025-122

A Resolution to make appropriations for current expenses for the City of Mount Vernon, State of Ohio, during fiscal year ending December 31, 2026.

### RESOLUTION NO. 2025-125

A Resolution authorizing the Safety-Service Director to accept the donation of property from the Knox County Land Reutilization Corporation; and declaring an emergency.

### RESOLUTION NO. 2025-129

A Resolution authorizing the Safety-Service Director to dispose of vehicles in the Police Department not needed for public use by the City of Mount Vernon; and declaring an emergency.

### RESOLUTION NO. 2025-130

A Resolution authorizing the Safety-Service Director of the City of Mount Vernon to enter into an agreement to acquire in whole or in part of two parcels of property located within the City of Mount Vernon; and declaring an emergency.

### RESOLUTION NO. 2025-132

A Resolution authorizing and directing the Safety-Service Director of the City of Mount Vernon, Ohio to acquire Axon Enterprise, Inc. Taser 10 handheld conducted energy devices and related equipment and services for the Mount Vernon Police Department; and declaring an emergency.

### RESOLUTION NO. 2025-133

A Resolution authorizing and directing the Auditor of the City of Mount Vernon to create an additional expense line pursuant to O.R.C. 5705.09(F), make a supplemental appropriation to the new line; and declaring an emergency.
